As an example, GL&P recently handled a construction site accident case in which their client was seriously injured when a concrete pump hose struck him in the chest, causing him to be thrown off of scaffolding and onto a concrete slab. Investigation revealed that the pump hose had developed a blockage, and the pump truck operator, a subcontractor on the job-site, negligently increased air pressure in the hose without moving the hose away from the client. When the blockage blew out at high pressure, the pump hose whipped violently, striking the client and causing serious injuries from the fall onto the concrete slab.

Graham Lundberg & Peschel is proud of their heritage, and the reputation that they have earned from their years of hard work and commitment to champion the causes of their clients.
